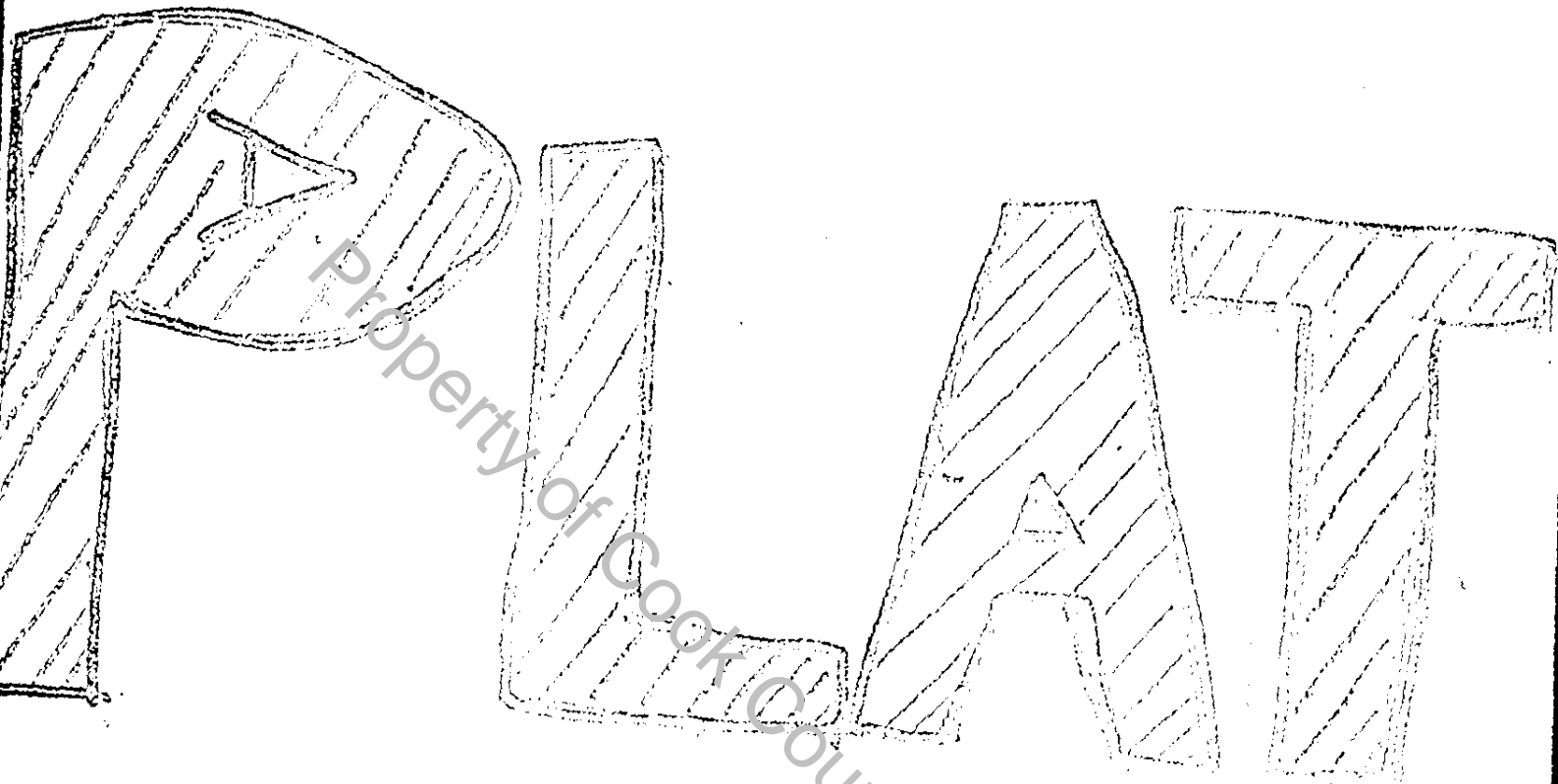

ORDINANCE NO: 2200

AN ORDINANCE ANNEXING PROPERTY (LECAS/SHENANDOAH)

BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois:

### SECTION 1

That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Orland Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Orland Park, Cook County, Illinois.
- (b) Such Petition was signed by all of the owners of record of such territory and by all electors who reside within said territory.
- (c) Such territory is not within the corporate limits of any municipality, but is contiguous to the Village of Orland Park, Cook County, Illinois, a municipality existing under the laws of the State of Illinois.
- (d) The Village of Orland Park, Cook County, Illinois, does not provide either fire protection or public library services and the territory proposed to be annexed is not part of any public library district.
- (e) Notice of the proposed annexation has been given to the Township Commissioner of Highways and Board of Town Auditors.

SECTION 2

The territory legally described as follows:

LOTS 11 TO 24 BOTH INCLUSIVE IN BLOCK 31 AND LOTS 1 THROUGH 46, BOTH INCLUSIVE IN BLOCK 32 IN ALPINE HEIGHTS, A SUBDIVISION OF THE SOUTHWEST 1/4 OF SECTION 20, TOWNSHIP 36 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT FROM SECTIONS 20 AND 29 THOSE PARTS THEREOF CONVEYED TO WABASH, ST. LOUIS AND PACIFIC RAILROAD FOR DEPOT SITE AND RIGHT-OF-WAY BY DEED MADE BY HARLOW P. SMITH AND WIFE DATED OCTOBER 28, 1882 AS DOCUMENT 369125 IN BOOK 1169, PAGE 34) IN COOK COUNTY, ILLINOIS.

AND

THAT PART OF THE SOUTHWEST 1/4 OF SECTION 20, TOWNSHIP 36 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: COMMENCING WHERE THE EASTERLY LINE OF THE DEPOT GROUNDS OF THE NORFOLK AND WESTERN RAILROAD (FORMERLY THE WABASH, ST. LOUIS AND PACIFIC RAILROAD) CROSSES THE NORTH LINE OF THE PUBLIC HIGHWAY RUNNING EAST AND WEST ON THE SOUTH SECTION LINE OF SAID SECTION 20, AND RUNNING THENCE NORTHEASTERLY WITH SAID EASTERLY LINE OF SAID DEPOT GROUNDS 100 FEET, THENCE EAST ON A LINE PARALLEL WITH SAID HIGHWAY 50 FEET; THENCE SOUTHERLY ON A LINE PARALLEL WITH THE EAST LINE OF SAID DEPOT GROUNDS TO THE NORTH LINE OF SAID HIGHWAY, THENCE ON THE NORTH LINE OF SAID HIGHWAY 50 FEET TO THE POINT OF BEGINNING.

THE PROPERTY CONTAINS APPROXIMATELY FIVE (5) ACRES AND IS AT THE NORTHWEST CORNER OF 167TH STREET AND 108TH AVENUE;

be and the same is hereby annexed to the Village of Orland Park, Cook County, Illinois, all in conformance with and as shown on a plat and map of annexation of said territory prepared by a registered land surveyor of the State of Illinois, attached hereto and made a part hereof as EXHIBIT A.

- (b) a plat of the land included in this annexation, as required by law, said plat to be attached to the aforesaid certified copy of this Ordinance.

**SECTION 4**

This Ordinance shall be in full force and effect from and after its adoption and approval as required by law.
