This EXTENSION AGREEMENT, made this 14th day of JUNE 19 92 by and between AMALGAMATED TRUST & SAVINGS BANK, an Illinois banking corporation, BANK OF CHICAGO the owner of the mortgage or trust deed hereinafter described, and

GREGORY W. BAISE AND TONYA J. BAISE, HIS WIFE 92465201 representing himself or themselves to be the owner or owners of the real estate hereinafter and in said deed described ("Owner"), WITNESSETH:

1. The parties hereby agree to extend the time of payment of the indebtedness evidenced by the principal promissory note or notes of OWNERS dated JUNE 14, 19 91, secured by a mortgage or trust deed in the nature of a mortgage recorded JUNE 27, 19 91 in the office of the Cook County Recorder of Deeds COOK County, Illinois in book _____ at page _____ as document No. 91314449 conveying to

Amalgamated Trust & Savings Bank, as Trustee, BANK OF CHICAGO certain real estate in COOK County, Illinois described as follows: LOT 117 IN EQUESTRIAN ESTATES UNIT NUMBER 8, A SUBDIVISION OF PART OF THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 25, TOWNSHIP 37 NORTH, RANGE 11, EAST OF THE THRID PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS

2. The amount of principal remaining unpaid on the indebtedness is \$ 318,262.86

3. Said remaining indebtedness of \$ 318,262.86 plus interest from this date on the balance of principal remaining from time to time unpaid at the simple annual rate of 7 1/2 per cent shall be paid in installments of principal and interest as follows:

TWO THOUSAND TWO HUNDRED FIFTY TWO AND 14/100-----Dollars (\$ 2,252.14) on the 14TH day of JULY, 1992, and A LIKE AMOUNT OF Dollars (\$ 2,252.14) on the 14TH day of each MONTH thereafter until said indebtedness is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 14TH day of JUNE, 19 93

and the Owner in consideration of such extension promises and agrees to pay the entire indebtedness secured by said mortgage or trust deed plus interest as and when therein provided, as hereby extended, and to pay interest after maturity or default at the rate of 11 1/2 per cent per annum; and to pay both principal and interest in the coin or currency provided for in the mortgage or trust deed hereinabove described, but if that cannot be done legally here in the most valuable legal tender of the United States of America current on the due date thereof, or the equivalent in value of such legal tender in other United States currency, at such banking house or trust company in the City of Chicago as the holder or holders of the said principal note or notes may from time to time in writing appoint, and in default of such appointment then at Amalgamated Trust & Savings Bank, One West Monroe Street, Chicago, Illinois 60603.

4. If any part of said indebtedness or interest thereon be not paid at the maturity thereof as herein provided, or if default in the performance of any other covenant of the Owner shall continue for twenty days after written notice thereof, the entire principal sum secured by said mortgage or trust deed, together with the then accrued interest thereon, shall, without notice, at the option of the holder or holders of said principal note or notes, become and be due and payable, in the same manner as if said extension had not been granted.

5. This Extension Agreement is supplementary to said mortgage or trust deed. All the provisions thereof and of the principal note or notes, including the right to declare principal and accrued interest due for any cause specified in said mortgage or trust deed or notes, but not including any prepayment privileges unless herein expressly provided for, shall remain in full force and effect except as herein expressly modified. The Owner agrees to perform all the covenants of the grantor or grantors in said mortgage or trust deed. The provisions of this Extension Agreement shall inure to the benefit of any holder of said principal note or notes and interest notes and shall bind heirs, personal representatives and assigns of the Owner. The Owner hereby waives and releases all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois with respect to said real estate. If the Owner consists of two or more persons, their liability hereunder shall be joint and several.
