15TH day of THIS PLANNED UNIT DEVELOPMENT RIDER is made this JUNE , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed 1992 of Trust or Security Deed (the "Security Instrument") of the same date, given by the undersigned (the "Borrower") to secure Borrower's Note to MIDLAND FINANCIAL MORTGAGES, INC. (the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 122 WHITE PINE, SCHAUMBURG, ILLINOIS The Property Includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in THE COVENANTS, CONDITIONS AND RESTRICTIONS OF RECORD (the "Declaration"). The Property is a part of a planned unit development known as SARAH'S GNOVE TOWNHOME ASSOCIATION es of Planned Unit Development) The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and facilities of the PUD (tha "Owners Association") and the uses, benefits and proceeds of Borrower's Interest. PUD COVENANTS in addition to the covenants and agreements made in the Security Instrument, Borrower and Lender faither covenant and agree as follows: A. PUD OBLIGATIONS. Borrower shall perform all of Borrower's obligations under the PUD's Constituent Documents. ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Sorrower and Lender further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note:

1. CONDITIONAL MODIFICATION AND EXTENSION OF LOAN TERMS
