Bank is willing to grant such request pursuant to the terms and conditions of a Note dated June 15, 1992 in the principal sum of Forty Thousand Dollars and No/100 (\$40,000) ("Second Replacement Note")

NOW THEREFORE, in consideration of the above regitals, the parties hereto do hereby agree and acknowledge as follows:

- Mortgagor does hereby acknowledge that the Mortgage and other applicable Security Documents are in full force and effect.
- 2. The Mortgage and other Security Documents are hereby modified to provide that such instruments are also granted as collateral security for repayment of the Second Replacement Note.
- In all other respects, the Mortgage and other applicable Security Documents are hereby ratified and reaffirmed.
