AN ORDINANCE ANNEXING THE PARK DISTRICT OF OAK FUREST, COUR COUNTY, ILLINOIS, PROPERTY WITHIN THE CITY OF OAK FUREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS

WHEREAS, Section 3-10 of Chaper 105 of the Illinois Revised Statues of 1965 provides that a Park District may annex by Ordinance all that territory within a City or Village in which said Park District operates: and

WHERKAS, the Commissioners of the Uak Forest Park District. Cook County, Illinois, have considered the question of the innexation of the territory hereinafter described and have differented that said territory is within the City of Uak Forest, Cook County, Illinois, and is contiguous to the territory of the Uak Forest Park District of Cook County, Illinois, and that the residents thereof currently use the facilities of said Park District and will in the future use and need additional facilities in such areas for recreation and park purposes: and

WHENEAS, it is to the best interests of all of the residents of said Park District and to be in the best interests of the residents, the voters and owners of the territory hereinafter respribed to become a part of the Uak Forest Park District.



NOW THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF THE OAK FOREST PARK DISTRICT:

Section 1. That the territory hyperinafter described, said territory described in this Ordinance, and specifically by reference made a part hereof, which said territory being contiguous to the territory of the Uak Forest Park District of Cook County, Illinois, and not within held Park District, or any other Park District, and within the provisions of said Chapter 105, Section 3-10 of the Illinois Revised Statues of 1965 be and the same is hereby annexed to the Colk Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows to wit:

LOT 1 IN BLOCK 36 IN ARTHUR T. MC INTOSH'S ADDITION TO MIDLOTHIAN FARMS, HEING A SUBDIVISION OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 AND THE EAST 1/2 OF THE SOUTHEAST 1/4 OF SECTION 9, AND THE WEST 1/2 OF THE SOUTHWEST 1/4 OF THE WEST 39/80THS OF THE EAST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 10, TOWNSHIP 36 NORTH, MANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

and which said tract of land above described and in the attached description is intended to be all in the territory within the City Limits of the City of Uak Forest not previously included within the Uak Forest Park District.
