That said owner is entitled to credits in the amount of Seven Hundred Eighty-nine Thousand Eight Hundred Thirty-seven and 89/100 (\$789,837.89) for partial payment, leaving due, unpaid and owing to DiPaolo Company, after allowing all credits, the balance of Two Hundred Seven Thousand Three Hundred Six and 85/100 (\$207,306.85) Dollars, for which, with interest, DiPaolo Company claims a lien on said land and improvements.


