LOT THIRTY FIVE (35) IN BLOCK SEVEN (7), IN THE WALSH AND McMULLEN'S SUBDIVISION OF THE SOUTH THREE-QUARTERS (3/4) OF THE SOUTH EAST QUARTER (1/4) OF SECTION 20, TOWNSHIP 39 NORTH RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not and it is agreed that all same or appurtenances or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting a part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which rights and benefits the Mortgagors do hereby expressly release and waive.

This trust deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the mortgagors, their heirs, successors and assigns.
