1. BORROWER'S PROMISE TO PAY

2. PAYMENTS FOR TAXES AND INSURANCE

(A) Borrower's Obligations

(B) Impound/Escrow Accounts

I will give Lender all notices or bills that I receive for the amounts due under this Paragraph 2.

(ii) Lender's Obligations

If I make my payments to Lender, Lender will estimate from time to time my yearly taxes, hazard insurance premiums, assessments, leasehold payments, ground rents and mortgage insurance premiums, which items will be called the "Impound/Escrow Items." Lender will use existing assessments and bills and reasonable estimates of future assessments and bills to estimate the Impound/Escrow Items. The amounts that I pay to Lender for Impound/Escrow Items under this Paragraph 2 will be called the "Funds."

Lender may hold the funds. Except as described in this Paragraph 2, Lender will use the funds to pay the impound/Escrow items. Lender will give to me, without charge, an annual statement of Funds activity.

Londer may not charge me for holding or keeping the Funds, for using the Funds to pay impound/Escrow none, for analyzing my payments of Funds, or for receiving, verifying and totaling assessments and bills. However, center may charge me for these services if Lender pays me interest on the Funds and if the law permits Lender to make such a charge. (iii) Adjustments to the Funds

If Lender's estimates of the Impound/Escrow Items are too high, the amounts that I pay under this Paragraph 2 will be too large.

If an excess of Funds remains after all Impound/Escrow Items have been paid and if I am keeping all of my promises and agreements made in this Security Instrument, then I will have the right to have the excess amount refunded directly to me, if a meeds \$25.00, or credited to my future monthly payments of Funds. Any refund or credit to which I am entitled will be made once a year.

If, at the time payments of impound/Cro.ow items are due, Lender has not received enough Funds to make those payments, it will pay to Lender unriever additional amount its necessary to pay the impound/Escrow items in full. When I have paid all of the amounts due under the Secured Notes and under this Security Instrument, Lender will promptly refund to me any Funds that are then being held by Lender. 3. APPLICATION OF BORROWER'S PAYMENTS

Unless the law requires otherwise, Lender will apply each of my paymentr under the Secured Notes and under Paragraphs 1 and 2 above in the following order and for the following purposes:

First, to pay tate charges due under the Secured Notes;
Second, to pay prepayment charges due under the Secured Notes;
Third, to pay any advances due to Lender under this Security Instrument;
Fourth, to pay the amounts due to Lender under Paragraph 2 above;
Fifth, to pay interest due under the Secured Notes;
Sixth, to pay deferred interest under the Secured Notes;
Last, to pay principal due under the Secured Notes.

4. BORROWER'S OBLIGATION TO PAY CHARGES, ASSESSMENTS AND CLAIMS

I will pay all laxes, assessments and any other charges and fines that may be imposed on the Property and that may be superior to this Security Instrument.

I will also make payments due under my lease if I am a tenant on the Property and I will pay ground rents (if any) due on the Property. I will pay these amounts either by making the payments to Lender that are described in Paragraph 2 above or by making the payments on time to the Person owed them.

Any claim, demand or charge that is made against property because an obligation has not been fulfilled is known as a fien. I will promptly pay or satisfy all liens against the Property that may be superior to this Security Instrument. However, this Security Instrument does not require me to satisfy a superior lien it: (A)—I agree, in writing, to pay the obligation which gave rise to the superior flen and Lender approves in writing the way in which I agree to pay that obligation; or (B) in good faith, I argue or defend against the superior flen in a lawsuit so that, during the fawsuit, the superior flen may not be enforced and no part of the Property must be given up; or (C) I secure from the holder of that other lien an agreement, approved in writing by Lender, that the

If Lender determines that any part of the Property is subject to a superior lien, Lender may give to me a notice identifying the superior lien. I will pay or satisfy the superior lien or take one or more of the actions set forth above within 10 days of the giving of notice.

5. BORROWER'S OBLIGATION TO MAINTAIN INSURANCE

At my sole cost and expense, I will obtain and maintain heard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, heards normally covered by "extended coverage" heard insurance policies and other heards for which Lender requires coverage. The insurance must be in the amounts and for the periods of time required by Lender. I may choose the insurance company but my choice is subject to Lender's approval. Lender may not refuse to approve my choice unless the refusal is reasonable. All of these insurance policies and renewals of the policies must include what is known as a **Standard Mortgages Clauss** to protect Lender. The form of all policies and renewals must be acceptable to Lender. Lender will have the right to hold the policies and renewals. If Lender requires, I will promptly give Lender all receipts of paid premiums and renewal notices that I receive.

If I obtain earthquake insurance, any other hazard insurance, credit life and/or disability insurance, or any other insurance, or or relating to the Property or the Secured Notes and which are not specifically required by Lender, I will name Lender as loss payee of any proceeds.

If there is 2005 or damage to the Property, I will promptly notify the proper insurance company and Lender. If I do not promptly prove to the insurance company that the loss or damage occurred, then Lender may do so.

The amount paid by the insurance company is called "Proceeds." Any Proceeds received will be applied first to reimburse Lender for costs and expenses incurred in connection with obtaining the Proceeds, and then, at Lender's option and in the order and proportion as Lender may determine in its sole and absolute discretion, regardless of any impairment or lack or impairment of security, as follows: (A) to the extent allowed by applicable law, to the Sums Secured in a marner that Lender determines and/or (B) to the payment of costs and expenses of necessary repairs or to the restoration of the Property to a condition satisfactory to Lender, such application to be made in the manner and at the times as determined by Lender.

If I abandon the Property or if I do not recover, within 30 days, a notice from Lender stating that the insurance company has offered to settle a claim, Lender may collect the Proceeds. Lender may use the Proceeds to repair or restore the Property or to pay the Sums fecured. The 30-day period will begin when the notice is given.

If any Proceeds are used to reduce the amount of principal which towe to Lender under the Secured Notes, that use will not delay the due date or change the amount of any of my monthly payments under the Secured Notes and under Paragraphs 1 and 2 above. However, Lender and I may agree in writing to delays or changes.

If Lender acquires the Property under Paragraph 27 below, all of my rights in the insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred before the Property is acquired by Lender or sold will belong to Lender. However, the lends rights in those proceeds will not be greater than the Sums Secured Immediately before the Property is acquired by Lender or sold.

If I am required by Lender to pay premiums for mortgage insurance, I will buy the premiums until the requirement for mortgage insurance ends according to my written agreement with Lender or according to law.

6. BORROWER'S OBLIGATION TO MAINTAIN THE PROPERTY AND TO FILFILL ANY LEASE OBLIGATIONS

I will keep the Property in good repair. I will not destroy or substantially change the Propert, and I will not allow the Property to deteriorate. I will keep and maintain the Property in compliance with in, state or federal negardous materials and hazardous waste laws. I will not use, generate, manufacture or store any hazardous materials or hazardous waste on, under or about the Property. I will indemnify, defend and hold harmless Lender and its employees, officers and directors and their successors from any claims, damages or costs for required or necessary repair or the removal of hazardous waste or any other hazardous materials claim. If I do not own but am a tenant on the property, I will fulfill my obligations under my lease. I also agree that, if I acquire the fee title to the Property, my lease interest and the fee title will not merge unless Lender agrees to the merger in writing.

7. LENDER'S RIGHT TO PROTECT ITS RIGHTS IN THE PROPERTY

II: (A) I do not keep my promises and agreements made in this Security Instrument, or (B) someone, including me, begins a legal proceeding that may significantly affect Lender's rights in the Property (such as a legal proceeding in bankruptcy, in probate, for condemnation or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the Lender's rights in the Property. I assign to Lender all my rights: (A) to proceeds of all awards or claims for damages resulting from condemnation, eminent domain or other governmental taking of all or any part of the Property; and (B) to proceeds from r sale of all or any part of the Property that is made to avoid condemnation, eminent domain or other government to in of the property. All of those proceeds will be paid to Lender.

If all of the fronerty is taken, the proceeds will be used to reduce the Sums Secured. If any of the proceeds remain after the amount that I owe to Lender has been paid in full, the remaining proceeds will be paid to me. Unless Lender and I rules otherwise in writing, if only a part of the Property is taken, the amount that I owe to Lender will be reduced only by the amount of proceeds multiplied by the following fraction: (A) the total amount of the Sums Secured immediately before the taking, divided by (B) the fair market value of the Property immediately before the faking. The remainder of the proceeds will be paid to me.

If I abandon the Property or in 1 to not answer, within 30 days, a notice from Lender stating that a governmental authority has offered to nake a payment or to settle a claim for damages, Lender has the authority to collect the proceeds. Lender may then use the proceeds to repair or restore the Property or to reduce the Sums Secured. The 30-day period will begin whim the notice is given.

MODIFICATION

This Security Instrument may be modified or amended only by an agreement in writing signed by Borrower and Lendar.

CONDOMINIUM, COPERATIVE AND PLANNED UNIT DEVELOPMENT OBLIGATIONS

If the Property is full in a condominium, cooperative or planned unit development, each of which shall be called the "Project," and have an interest in the common elements of the Project, then Lender and I agree

- (A) If an owners association or other entity, called "Owners Association," holds title to Property for the benefit or use of the Project and its members or shareholders, the Property also includes my Interest in the Owners Association and the uses, proceeds and benefits of my interest.
- (B) The following are called the "Constituent Documents:" (I) The declaration or any other document which created the Project; (ii) By-laws of the Oymers Association; (iii) Code of regulations for the Project; (iv) Articles of incorporation, trust instrument or equivalent di cument which creates the Owners Association; (v) The Project's covenants, conditions and restrictions; (vi) Other equivalent documents.

I shall perform all of my obligations under the Constituent Documents, including my obligation to pay, when due, all dues and assessments. If I do not pay the cues and assessments when due, Lender may, at its option, pay them. I will pay to Lender any amounts which Lender advances under this Paragraph 24 according to the terms described in Paragraph 7 above.

(C) If the Owners A sociation maintains, with an insurance company reasonably acceptable to Lender, a master or blanket policy on the Project which is satisfactory to Lender and which provides insurance coverage on the terms, in the amounts, for the periods, and against the hize do Lender requires, including like and hazards included within the term "extended coverage," and Lender is provided with evidence of such master or blanket policy, then: (I) Lender waives the provision in Paragraph 2(B) above for the monthly payment to Lender of one-twelfth of the estimated yearly premium installments for hazard insurance on the Property; and (ii) hazard insurance coverage on the Property as required by Paragraph 5 above is deemed to be satisfied to the extent that the required coverage is provided by the Owners Association policy. In the event of a distribution of hazard insurance proceeds in lieu of restoration or repair 23 following a loss to the Property, whether to the unit or to common elements, any proceeds payable to me are 🗸 hereby assigned and shall be paid to Lender for application to the Sums Secured by this Socurity Instrument, with any excess paid to me.

I shall take such actions as may be reasonable to insure that the Owners Association maintains a public fiability insurance policy acceptable to Lender in form, amount and extent of coverage.

(D) I shall not, except after notice to Lander and with Lender's prior written consent, either partition or subdivide the Property or consent to; (i) the abandonment or termination of the Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of condemnation, eminent domain or other governmental taking; (ii) any amendment to any provision of Constituent Documents unless the provision is for the express benefit of Lender or of londers generally; (III) termination of professional management and assumption of self-management of the Owners Association; or (iv) any action which would have the effect of rendering the master or blanket hazard insurance policy and/or the public liability insurance coverage maintained by the Owners Association unacceptable to Lender.

25. FUTURE ADVANCES

If there is a Breach of Duty by me, Lender may demand an immediate payment of all sums secured.

If there is a Breach of Duty by me, the Lender may take action to have the Property sold under any applicable Federal Law, rule or regulation and, where Federal Law is not applicable, under the law of the state where the Property is located, which will be called the "Applicable Law."

Lender does not have to give me notice of a Breach of Duly unless notice is required by Applicable Law. If Lender does not make a demand for full payment upon a Breach of Duly, Lender may make a demand for full payment upon any other Breach of Duly.

If there is a Breach of Outy, Lender may also take action to have a receiver appointed under the Applicable Law to collect rents from any tenants on the Property and to manage the Property. The action to appoint a receiver may be taken without prior notice to me and regardless of the value of the Property.
