5. Hazard or Property Insurance. Regrower shall keep the implementation washing or hereafter breezed on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which Lender requires insurance. 16. Borrower's Copy. Borrower shall be given and conformed copy of the Property instrument.

17. Transfer of the Property or a Beneficial Interest in Borrower.
