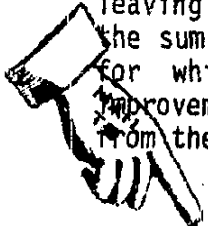
That on October 9, 1991, the owner(s) owned the following described land in the County of Cook, State of Illinois:

That on October 9, 1991, said contractor made a subcontract with the claimant to furnish lumber, millwork and miscellaneous building materials for and in said improvement, and that on March 17, 1992, the claimant completed thereunder all required to be done under the aforementioned agreement by the delivery of said materials to the value of SIXTY-FOUR THOUSAND SEVEN HUNDRED FIFTY-ONE DOLLARS AND 28/100 (\$64,751.28).

That said contractor is entitled to credits on account thereof as follows: FIFTY-FOUR THOUSAND FIVE HUNDRED TWENTY-SIX DOLLARS AND 81/100 (\$54,526.81), leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of TEN THOUSAND TWO HUNDRED TWENTY-FOUR DOLLARS AND 47/100 (\$10,224.47), for which, with interest, the claimant claims a lien on said land and improvements and on the monies or other considerations due or to become due from the owner under said contract against said contractor and owner.

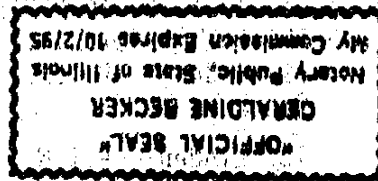
