THIS INDENTURE, dated this 26th day of June, 1992 WITNESSETH, as follows:

WHEREAS, Commonwealth Edison Company, an Illinois corporation (hereinafter called the "Company"), has heretofore issued \$140,000,000 principal amount of its First Mortgage 8-7/8% Bonds, Series 64, due June 15, 1994, (the "bonds of Series 64"), pursuant to the provisions of its Supplemental Indenture dated June 15, 1987, supplemental to its Mortgage dated July 1, 1923, as amended and supplemented by Supplemental Indenture dated August 1, 1944, and subsequently executed supplemental indentures (said Mortgage as so amended and supplemented being hereinafter called the "Mortgage"), Continental Bank, National Association being now the Trustee and M. J. Kruger being now the Co-Trustee under the Mortgage; and

WHEREAS, said Supplemental Indenture dated June 15, 1987, has been recorded in the offices of the Recorder of Deeds in certain counties of the State of Illinois, as follows:

NOW, THEREFORE, in consideration of the premises and of the sum of Ten Dollars (\$10) and of other good and valuable consideration duly paid by the Company to the Trustees, the receipt of which is hereby acknowledged, Continental Bank, National Association and M. J. Kruger, Trustees under the Mortgage, do hereby REMISE, CONVEY, RELEASE and QUIT-CLAIM unto Commonwealth Edison Company all the estate, right, title, interest, claim and demand whatsoever which the Trustees may have acquired in, through or by said Supplemental Indenture dated June 15, 1987; and the Trustees do hereby acknowledge satisfaction of all of the bonds of Series 64, and do hereby authorize the Recorder of Deeds of the several counties of the State of Illinois and the several counties of the State of Colorado, in which said Supplemental Indenture dated June 15, 1987, is recorded to cancel and discharge said Supplemental Indenture dated June 15, 1987, and to enter satisfaction thereof on the records in their respective offices;


