#### TPMPORARY RESTRAINING ORDER

This cause coming on for hearing upon the Petition for the Petitioner, EUGENIA SUSK, for a Temporary Restraining Order against the Respondent, MYRON LEE SUSK. the court having read and considered the Verified Petition for a Temporary Restraining Order and Preliminary Injunction and being fully advised in the premises, FINDS:

- A. That it has jurisdiction over the solvect matter herein.
- B. That a proper basis exists for the issuance of a temporary restraining order against the Respondent, MYkON LEE SUSK.
- C. That there has been a showing that immediate and irreparable injury may be caused to the Petitioner before notice can be served and a hearing had thereon by reason of Respondent's acts to transfer marital assets, and that if the Respondent learns that the Petitioner has taken any legal action before a hearing can be held the Petitioner shall suffer the loss of her assets which may not otherwise be remedied.
  - D. Petitioner has no adequate remedy at law.

- E. Petitioner has a reasonable likelihood of success on the merits.
- F. Petitioner has a certain and clearly ascertainable right which needs protection.
- G. Good cause has been shown for the entry of this order without notice and without bond.

#### IT IS HEREBY ORDERED THAT:

- 1. The Respondent, MYRON LEE SUSK, and all of his agents, assigns, employees, servants, attorneys and all those acting in active concert and participation with him, are enjoined and restrained from removing, selling, transferring, assigning, pledging, hypothecating, dissipating, diverting and disposing of assets in which EUGENIA SUSK and/or MYRON LEE SUSK hold an interest, legal or equitable, present or future, except in the ordinary course of business or for the necessities of life, including but not limited to all funds on deposit at Boulevard Bank, and the property located at 1525 North Wells, Chicago, Illinois, subject to Respondent's ability to petition this Court to allow him leave to sell the property and escrew the sales proceeds.
- 2. The Respondent, MYRON LEE SUSK, will be permitted to enter the marital home to remove his clothing only when the Petitioner, EUGENIA SUSK is present, and on twenty-four (24) hours notice to EUGENIA SUSK.
- 3. This temporary restraining order shall remain in full force and effect through and including the 3rd day of August, 1992, at 5:00 p.m., or until such other times as may be extended by the

court.

- 5. The hearing on the Petitioner's Petition to Extend this Temporary Restraining Order or, in the alternative, for a preliminary injunction, shall be set for the 3rd day of August, 1992 at 3:30 a.m. in Room 1905.
