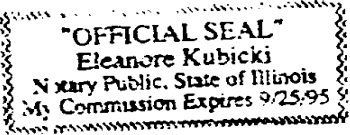

## Legal Description

The land referred to in this Document is located in the County of Cook, State of Illinois and described as follows:

That part of lot 27 in Leonard Hodge's Subdivision of parts of sections 16 and 17, Township 41 North, range 12 East of the Third Principal Meridian, described as follows: Beginning at the point of intersection of a line drawn parallel with and 199.22 feet Northerly of the Southerly line of the Northerly half of lot 26 in Hodge's Subdivision, aforesaid and a line drawn parallel with and 400 feet Easterly of the center line of Hawthorne Lane; thence Northerly on a line parallel with the center line of Hawthorne Lane 151.7 feet more or less to the Northerly line of said lot 27, thence Westerly along the Northerly line of said lot 27, 60 feet; thence Southerly parallel with the center line of Hawthorne Lane to said line parallel with and 199.22 feet Northerly of the Southerly line of the Northerly half of lot 26 aforesaid; thence Easterly along said last described line 60 feet to the place of beginning, in Cook County, Illinois.
