That part of Lot 27 in Resubdivision of Hills and Dales, a Subdivision of part of Section 10, Township 42 North, Range 9 East of the Third Principal Meridian, described as follows:

Beginning at a point on the Easterly line of said Lot 27 (being also the Northwesterly right of way line of the Elgin, Joliet and Eastern Railroad) at a point 977.96 feet Southwesterly from the Northeasterly corner of said Lot 27 for a point of beginning, thence Westerly along a line forming an angle of 116 degrees 04 minutes from the Northeasterly to North Westerly with the last described line a distance of 315.75 feet to a point on the Easterly line of Hills Road in said Subdivision lying 141.28 feat Northerly from a point of curvature of a curve having a radius of 544.30 feet; thence Southwesterly along said Easterly line of Fills Road on a straight line forming an angle of 108 degrees 50 minutes from Easterly to South and Southwesterly with the last described course a distance of 141.28 feet; therce Southwesterly along said Southeasterly line of Hills Road along a curve to the right naving a radius of 544.30 feet a distance of 154.75 feet; thence Southwesterly along said southeasterly line of Road on a straight line tangent to the last described curve a distance of 6.0 feet; thence Southwesterly along the said Southeasterly line of rold on a curve to the right having a radius of 639.70 feet a distance of 320.77 feet; themes Southwesterly along said Southeasterly line of road on a straight line tangent to the last said curve, a distance of 64.35 feet; thence Southwesterly along said Southeasterly line of Hills Road on a curve to the right having a radius of 259.20 feet, Adistance of 83.85 feet to the most Westerly line of said Lot 27; thence Southerly along the said most Westerly line of Lot 27 a distance of 10.36 feet to a point on the South line of said Lot 27 lying 573.3 feet Westerly from the Southeasterly corner of said Lot 27, thence Easterly on the said South line of Lot 27 a distance of 573.3 feet to the said Southeasterly corner of Lot 27 on the Northwesterly right of way line of said Elgin, Jolist and Eastern railroad; thence Northeasterly along said Northwesterly right of way line of Railroad a distance of 550,24 feet to the point of beginning, all in Township of Barrington, in Cook County, Illinois.
