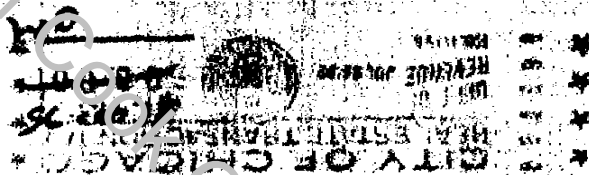

Howard A. Hammersley 540 N. Lake Shore Drive, Chicago Illinois 60611 party of the second part.

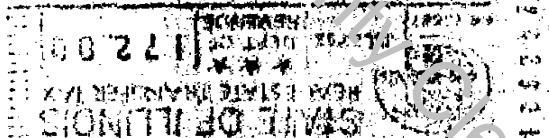

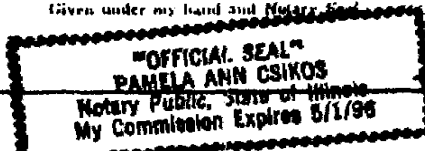

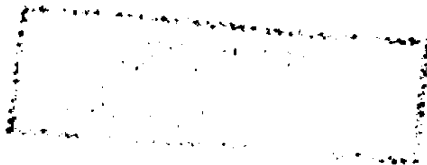


EXHIBIT A
