WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board, approved in writing by the acknowledged signatures of all of the Board members and by at least three-fourths (3/4) of the unit owners, and due notice having been provided to all mortgagees holding liens of record against any unit ownership, all in compliance with Article XIX, Section 6 of the Declaration and Section 17 of the Act.

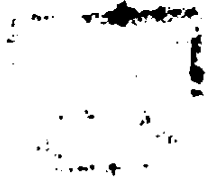
This amendment is adopted pursuant to the provisions of Article XIX, Section 6 of the aforesaid Declaration and Section 17 of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed and acknowledged by all of the members of the Board, and by at least three-fourths (3/4) of the unit owners and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees, having liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration"), for the East Condo Association (hereafter the "Association"), which Declaration was recorded on August 18, 1986, as Document No. 86360154 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part hereof.

END OF TEXT OF AMENDMENT

2. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.

(e) The restrictions contained in subparagraph (b) shall not apply to the keeping of guide dogs by the physically handicapped owners or occupants of units.

(d) The restrictions contained in subparagraph (b) shall not apply to a lessee or sublessee of a unit who is a lessee or sublessee of the unit on or before the effective date of this amendment; provided that said dog is not causing or creating a nuisance.

(c) The restrictions contained in subparagraph (b) shall not apply to the keeping of dogs as a household pet by any unit owner who owns the unit on or before the effective date of this amendment; provided that said dog is not causing or creating a nuisance.

(b) The foregoing notwithstanding, no dogs are permitted to be kept in or brought into or onto any unit or the common elements for any purpose whatsoever.

(a) No animals, reptiles, rabbits, livestock, fowl or poultry of any kind shall be raised, bred or kept in any unit or in the common elements, except that household pets, other than dogs except as hereinafter provided, may be kept in units, subject to rules and regulations adopted by the Board, provided that they are not kept, bred or maintained for any commercial purpose, and provided further that any such pet causing or creating a nuisance or unreasonable disturbance shall be permanently removed from the property upon three (3) days written notice from the Board.

1. Article XVII, Section 8 is hereby amended as follows:

NOW THEREFORE, the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Wilshire East Condominium Association is hereby amended in accordance with the text which follows (Additions in text are indicated by underline; deletions by (X)):
