

Sec. 6321. Lien For Taxes

If any person liable to pay an, tax colocts or refuses to pay In any gerson mainter, any management in any gerson mainter demand, the amount, manning any interest, additional amount, addition to tax, or ser scable penalty, ingether, with any costs that may accr o in addition thereto), shall be a lien-in layer of the Upiled State "pen all property and rights to property, whether real or personal, belonging to such person. 1998/1988/1988/1988

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the flor imposed by section 6321 shall state at the time the assessment is made and shall continue until, the liability for the amount so assessed for a judgment against the taxpayer arising out of such liability is antiflued or becomes unaderceable by reason at tapes of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.—11n lien Imposod by section 6321 shall not be valid as against any purchas-st, holder of a security interest, mechanic's liener, or judg-ment lien creditor until notice thereof which meats the require-ments of subsection (f) has been filled by the Secretary.
