In Block 70m (B) sit in Section Second Northeast Subdivision, being a Subdivision of lots 6, 9, 12, 15 and 18 in Section Five (5) of the North Half (N) of the Northwest Quarter (NW) of the North East Half (NE) of the Northwest Quarter (NW) and the Southeast Quarter (SE) of the Northwest Quarter (NW) of Section 15 of Township 10, Range 16, East of the First Principal Meridian, and also that part lying West of the West Line of Road of the Northwest Quarter (NW) of Section 15, Township 10, Range 16, East of the Third Principal Meridian, and all in that District, likewise, excepting however, that part of lot 8 bounded on the South by a point on the West Line of subdivision lot 9, 24.25 feet West of the Southwest corner of said lot 8, running thence West along a line parallel with the South Line of said lot 8, a distance of 135 feet, thence Southwesterly parallel with the South line of said lot 8 a distance of 10.34 feet, thence West parallel with the South line of said lot 8, a distance of 135 feet to the West line of said lot 8, thence Southwesterly along the West line of said lot 8 a distance of 94.44 feet to the place of beginning, according to plan registered as Registered Number 10000.


