### AGREED PRELIMINARY INJUNCTION

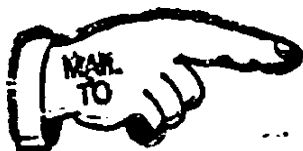
By agreement of the parties:

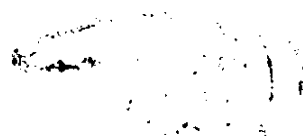

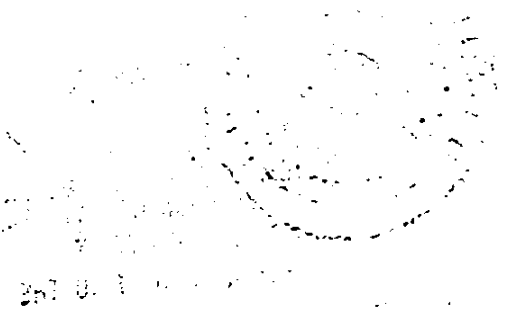


