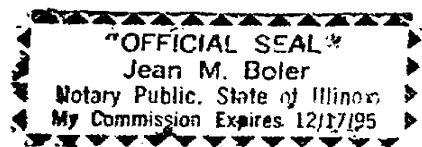

That part of the East 1/2 of the Southwest 1/4 of Section 9, Township 39 North, Range 12, East of the Third Principal Meridian, lying South of the center line of Butterfield Road described as follows: commencing at the intersection of the center line of Butterfield Road with the West line of the East 1/2 of the Southwest 1/4 of Section 9 aforesaid, thence South along West line of the East 1/2 of the Southwest 1/4 of said Section 9, 302.48 feet, thence Northeasterly parallel with the center line of Butterfield Road to the East right of way line of Bellwood Avenue, said point being the point of beginning, thence continuing North along the North extension of the East right of way line of Bellwood Avenue 79 feet, thence East 84 feet, thence South 52 degrees 22 minutes East 33 feet, thence South 3 degrees, 30 minutes 35 seconds West 24.36 feet, thence Southwesterly parallel with the center line of Butterfield Road 114 feet to the point of beginning in Cook County, Illinois.
