

ITEM 1. Units 10-G as described in survey delineated on and attached to and a part of a Declaration of Condominium Ownership registered on the 29th day of August, 1968, as Document Number 2407502.

ITEM 2. An Undivided 11.10% interest (except the Units delineated and described in said survey) in and to the following described Premises:

That part of LOT TWO (2), in Valley Le-Unit One, being a subdivision in Section 26, Township 42 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing at the most Northerly Northeast corner of said Lot 2 and running thence South along an East line of said Lot 2, a distance of 196.13 feet to the Northeast corner of said part of Lot 2 hereinafter described, and the point of beginning for the description thereof; thence continuing South along said East line of Lot 2, a distance of 74.70 feet; thence West along a line parallel with the most Northerly straight North line of said Lot 2, and the Westward extension of said parallel line, a distance of 300.74 feet to an intersection with the Northwesteasterly line of said Lot 2; thence Northerly along said Northwesteasterly line of Lot 2, a distance of 81.27 feet to an intersection with the Westward extension of a line which is 196.13 feet measured along said East line of Lot 2; South from and parallel with the most Northerly straight North line of said Lot 2, and thence East along said Westward extension and along said parallel line, a distance of 279.01 feet to the point of beginning.
