Section 1 of Article VI of the Illinois Constitution requires that the Board of Supervisors be composed of seven members, five of whom shall be elected by the voters of the county and two shall be appointed by the Governor.

The Board of Supervisors shall have the honor and dignity of the county, and shall be the guardian of the public property and funds of the county.

The Board of Supervisors shall have the right to raise and appropriate money for the purposes of the county, and to levy taxes for such purposes.

The Board of Supervisors shall have the right to sue and be sued in its corporate capacity, and to acquire, hold, and dispose of real and personal property.

The Board of Supervisors shall have the right to borrow money on the credit of the county, and to pledge the property of the county as security for such loans.

The Board of Supervisors shall have the right to charter a city or village within the county, and to dissolve such charter.

The Board of Supervisors shall have the right to divide the county into wards, and to elect a board of ward commissioners for each ward.

The Board of Supervisors shall have the right to elect a county clerk, a county treasurer, a county auditor, and such other officers as may be necessary for the proper administration of the county.
