- 7. The Partnership's profits, losses, gains, credits and distributions shall be allocated to the Partners in accordance with and in proportion to each Partner's Proportionate Share.
- 12. Upon any dissolution or termination of the Partnership, the affairs of the Partnership shall be wound up by the partners with reasonable speed and the assets of the Partnership, including the Property (except assets that the Partners agree to distribute in kind), shall be sold within a reasonable period of time with a view toward obtaining fair value therefor. The Partners shall continue to share profits, losses, gains, credits and distributions during the period of liquidation in the manner described in Paragraph 7. The proceeds from liquidation shall be applied in the manner described in Paragraph 13 below. Any asset (including the Property) distributed in kind shall be valued and treated, for purposes of accounting to and between the Partners, as though such asset were sold for cash and the cash proceeds were distributed.
- 13. The procesus from liquidation of the Partnership shall be distributed and applied in the following order of priority:
  - (a) to pay any currently due and payable debts or liabilities of the Partnership, except debts owed to any Partner;
  - (b) to establish or add to such reserves as the Partners may deem desirable, or as may otherwise be required by the terms of any agreement to which the Partnership is a party; provided, however, that at the expiration of such period of time as the Partners may deem advisable, the balance of such reserve shall be distributed in the manner hareinafter set forth in this Paragraph 13;
  - (c) to pay or repay any obligations or debts of the Partnership to any Partners, such obligations and debts to be satisfied in the order in which they were incurred, and part passu as to obligations incurred simultaneously; and
  - (d) to distribute proceeds not disbursed or reserved in accordance with the tdregoing provisions, if any, first to and among the Partners having positive balances in their capital accounts, in proportion to and to the extent of their respective positive balances; and second, the balance, if any, to and among the Partners in escordance with their Proportionate Share.
