## RTC ILLINOIS SPECIAL WARRANTY DEED

On November 22, 1991, Western Savings and Loan Association, was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5 (d) (2) (A) of the Home Owners Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"). OTS pursuant to order number 91-696 appointed the Resolution Trust Corporation ("RTC") as Receiver of Western Savings and Loan Association.

On November 22, 1991, The OTS by order number 91-696, chartered Western Federal Savings and Loan Association as a federal mutual savings bank, and pursuant to Section 5 (d)(2)(B)(i) of HOLA, appointed the RTC as Conservator for Western Federal Savings and Loan Association.

On March 20, 1992, the OTS by order number CHI-92-11 appointed the RTC as Receiver for Western Federal Savings and Loan Association.

NOW THEREFORE THIS SPECIAL WARRANTY DEED is made the 12th day of AUGUST, 1992, by RESOLUTION TRUST CORPORATION, as Receiver for WESTERN FEDERAL SAVINGS & LOAN ASSOCIATION, whose address is 950 Milwaukee Avenue, Glenview, Illinois, as GRANTOR, to Richard Paul, whose address is 276 Ashland Court, Buffalo Grove, IL 60089, as GRANTEE.

WITNESS that Grantor, for good and valuable consideration, receipt of which is acknowledged, remises, releases, aliens, conveys and warrants to Grantee all the real property commonly known as Unit #1219, 730 North Hicks Road, Palatine, Cook County, Illinois, more particularly described in Exhibit "A" which is attached hereto and made a part hereof and included herein by reference, together with all tenements, hereditaments and appurtenances thereto; subject to the covenants and restrictions as set forth in the Land Use Restriction Agreement executed by Grantor and Grantee concurrently with this deed and subject to current real property taxes, zoning and other governmental restrictions, Illinois Condominium Property Act, and all covenants, conditions, restrictions, easements, rights-of-way and other matters of record.

Grantor hereby covenants with Grantee that Grantor will forever defend Grantee against claims of all persons claiming by through or under Grantor. No other covenants or warranties express or implied, are given by this Special Warranty Deed.

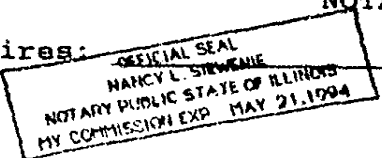
