ORDINANCE NO: 2239

AN ORDINANCE PROVIDING FOR THE VACATION OF CERTAIN PUBLIC STREETS AND ALLEYS IN THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS (SHENANDOAH RIDGE)

WHEREAS, a petition for the resubdivision of certain real estate has been filed with the Village Clerk of this Village and said resubdivision requires the vacating of certain public roads and alleys, as set forth below; and

WHEREAS, the Plan Commission of this Village held a public hearing on whether the requested resubdivision should be granted, at which time all persons present were afforded an opportunity to be heard; and

WHEREAS, the Plan Commission of this Village has filed its report of findings and recommendations for this resubdivision to be granted by this Acting President and Board of Trustees; and

WHEREAS, this Acting President and Board of Trustees of this Village after due investigation and consideration have determined that the public interests will be subserved by vacating said public streets and alleys.

NOW, THEREFORE, BE IT ORDAINED by the Acting President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

The certain public roads and alleys in Alpine Heights, a subdivision of the southwest quarter of Section 20, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois being more fully described as follows, to wit:

THE EAST HALF OF THE PART OF HAZEL AVENUE LYING SOUTH OF THE NORTH LINE OF LOT 46 IN BLOCK 32 EXTENDED WEST AND NORTH OF THE SOUTH LINE OF LOT 37 IN BLOCK 32 EXTENDED WEST; THAT PART OF HAZEL AVENUE LYING SOUTH OF THE SOUTH LINE OF LOT 37 IN BLOCK 32 EXTENDED WEST AND NORTH OF A LINE THAT IS 17.00 FEET NORTH OF AND PARALLEL WITH THE SOUTH LINE OF LOT 28 IN BLOCK 32 EXTENDED WEST; THE SOUTH HALF OF THAT PART OF SHERMAN STREET LYING WEST OF A LINE THAT IS 17.00 FEET WEST OF AND PARALLEL WITH THE EAST

LINE OF LOT 1 IN BLOCK 32 EXTENDED NORTH AND EAST OF THE CENTERLINE OF HAZEL AVENUE; ALL OF THE ALLEYS LYING WITHIN BLOCKS 31 AND 32 (EXCEPT THE EAST 17.00 FEET OF THAT PART THEREOF THAT IS NORTH OF AND ADJACENT TO LOTS 19 THROUGH 28 IN BLOCK 32), ALL IN ALPINE HEIGHTS, BEING A SUBDIVISION OF THE SOUTHWEST QUARTER OF SECTION 20, TOWNSHIP 36 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

as indicated by the clearly marked sections and by the words "HEREBY VACATED" on the plat hereto attached, which plat for greater certainty hereby is made a part of this ordinance BE AND THE SAME HEREBY IS VACATED inasmuch as the same is no longer required for public use and the best interests of the public will be subserved by such vacation as herein before set forth.

SECTION 2

All ordinances or parts of ordinances in conflict with the provisions hereof are hereby repealed insofar as they conflict herewith.

SECTION 3

A certified copy of this Ordinance shall be filed by the Village Clerk of the Village of Orland Park, Illinois, for record in the Office of the Recorder of Deeds of Cook County, Illinois.

SECTION 4

This ordinance shall take effect and be in full force from and after its passage and approval.


