YOU AND EACH OF YOU ARE HEREBY NOTIFIED that the Village of Streamwood, County of Cook, is about to annex the territory hereinafter described below pursuant to the provisions of Illinois Revised Statutes, Chapter 24, Article 7, Section 1, and that such annexation will take place not less than ten (10) days after the service of this notice upon you. Said real estate is located on the south side of Schaumburg Road, west of Route 59, adjacent to the Little Creek Subdivision. The Village of Streamwood has scheduled a Public Hearing on August 20, 1992 at 6:30 p.m. at the Village Hall, 301 East Irving Park Road, Streamwood, IL 60107 to consider an annexation agreement regarding this property.

The property is legally described as: That part of the Northeast Quarter of Section 21, Township 41 North, Range 9 East of the Third Principal Meridian, described as follows: commencing at the Northeast corner of said Section; thence Westerly along the North line of said Section 21, a distance of 673.12 feet to the East line of the West half of the East half of the Northeast Quarter of said Section 21; thence Southerly along said East line, a distance of 349.68 feet to the Southerly right of way line of Schaumburg Road for the place of beginning; thence continuing Southerly along said East line a distance of 2,343.01 feet to the South line of said Northeast Quarter; thence Easterly along said South line a distance of 6.3 feet; thence Northerly along a straight line, a distance of 2,351 feet to a point on the Southerly right of way line of Schaumburg Road that is 16.68 feet Northeasterly of (measured along said Southerly right of way line) the place of beginning; thence Southwesterly along said Southerly right of way line, a distance of 16.68 feet to the place of beginning, situated in Hanover Township, Cook County, Illinois.
