THAT, WHEREAS the Grantors have promised to pay to FORD CONSUMER FINANCE COMPANY, INC. referred to as the "Beneficiary," the legal holder of the Note hereinalter described, the principal amount of THEFTEN THOUSAND SEVEN HUNDRED ELGRICY NINE DULE AS AND FORLY SEVEN CENTS.

), together with interest the con, such indebtedness being evidenced by, secured by and payable 15 789.47 Dollars (\$ according to the terms of that certain Note of even date here with executed by Grantors and delivered to Beneficiary (the "Note").

Interest accrues under the Note at a variable interest rate. The Interest rate of the Note will increase or decrease with changes in the Prime Rate. The Prime Rate ("Index") is the highest Prime Rate published in the "Money Rates" section of The Wall Street Lournel. The interest rate is subject to change semi-annually, and will be determined by the sum of the Prime Rate plus a "Margin" as stated below. The date on which my interest rate will be subject to change is the "Rate Change Date." The date on which the value of the Prime Rate is examined for purposes of determining the interest rate is the Pate Determination Date," and will be the last business day of the second month prior to any Rate Change Date.

The Prime Rate as of the last business day of JULY 1992 6.000 percent, my Margin is percent; therefore, the "current" interest rate is 11, 750 percent per year.

However, until my sixth payment due date, my interestrate is discounted and will be 10,500 percent per year.

5.750 percentage points (Margin) greater than the Prime Beginning with the sixth payment due date, the interest rate will be Rate as of the last business day of the second month prior to the month in which the sixth paye ent is due (Rate Determination Date). Thereafter, the interest rate will increase on the twelfth payment due date and every six (6) morths thereafter (Rate Change Dates), if the highest Prime Rate as of the appropriate Rate Determination Date has increased or decreased by at least one-quarter of one (0.25) percentage point from the Prime Rate for the previous six month period. Interest rate changes will be effective upon (wenty-five (25) days written notice. During the first twelve (12) months, the interest rate cannot increase more than three per cent (3%) above the "cur rent" (bon discounted) interest rate. Thereafter, the interest rate cannot increase more than three percent (18 rin any twelve-month period from the date bereof. In no event, however, will the interest rate ever be less than 9.750 percent per year or more than eighteen percent (18%) per year. If the Index is no longer available, Beneficiary will choose a new index which is based upon comparable information. Beneficiary will give notice of this choice. Beneficiary reserves the right to waive part or al of any adjustment resulting from an interest rate increase. Grantors agree to pay interest after maturity at the interest rate that is in effect as of the maturity of the Note, until paid in full.

The Grantors promise to pay the said sum in the said Note in owed by  $-5^\circ$  at \$ = -213.95  $^\circ$ , followed by 114 at \$ 120 consecutive monthly installments: 1 at \$ followed by 223.79, followed by at\$ , with the first insta-Ilment being on and the remaining installment continuing on the same day each month thereafter until fully paid. All of said payments being made payable at such place as the Beneficiary or other holder may, from time to time, in writing appoint.

NOW, THEREFORE, the Grantors, to secure the payment of the said obligation in accordance with the terms, provisions and limitations of this Trust Deed, and the performance of the covenants and agreements herein contained, by the Grantors to be performed, and also in consideration of the sum of One Dolfar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trostee, its successors and assigns, the following described Real Estate and all of their estate, title and interest therein, situate, lying and being in the CITY οľ CHICAGO , COUNTY OF

TOGETHER with improvements and fixtures now attached together with casements, rights, privileges, interests, rents and profits.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Grantors do hereby expressly release and waive.

- 1. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other fiens or claims for lien not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Beneficiary; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Grantors shall pay before any penalty attaches all general taxes, and shall pay special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to Beneficiary duplicate receipts therefor. To prevent default hereunder Grantors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Grantor may desire to contest.
- 3. Grantors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, fig/duing or windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the Beneficiary, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the Beneficiary, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to Beneficiary, and in case of insurance about to expire, shall deliver renewal policies not less than ten day. This to the respective dates of expiration.
- 4. In case of default therein, costee or Beneticiary may, but need not, make any payment or perform any act hereinbefore required of Grantors in any form road manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbran road fany, and purchase, discharge, compromise or settle any tax lien or other prior title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or promise or settle any tax lien or other prior lien or title or claim the road, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorney's fe's, and any other moneys advanced by Trustee or Beneficiary to protect the premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the annual percentage rate stated in the Note this Trust Deed secures. Inaction of Trustee or Beneficiary shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of Grantors.
- 5. The Trustee or Beneficiary hereby secured making any pagment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax flen or title or claim thereof.
- 6. Grantors shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the option of Beneficiary, and without notice to Greeness, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the Note or in this Trust Deed to the corderty, become due and payable (a) immediately in the case of default in making payment of any installment on the Note, or (b) when default shall occur and continue for three days in the performance of any other agreement of the Grantors herein contained, or (c) immediately if all or part of the premises are sold or transferred by the Grantors without Beneficiary's prior written consent.
- 7. When the indebtedness hereby secured shall become due whether by acceleration or otherwise, Beneficiary or Trustee shall have the right to foreclose the lien hereof. In any sait to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Trustee or Beneficiary for attorney's fees, Trustee's fees, appraisers' fees, outlay for doen a many and expert evidence, steing-raptiers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, guarantee policies, Torrens e intificates, and similar data and assurances with respect to title as Trustee or Beneficiary may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the different value of the premises. All expenditures and expenses of the nature in the paragraph mentioned shall become so much ad ational indebtedness secured hereby and immediately due and payable, with interest thereon at the annual percentage rate stated in the Note this Trust Deed secures, when paid or incurred by Trustee or Beneficiary in connection with (a) any proceeding, in the ling probate and bankruptey proceedings, to which either of them shall be a party, either as plaintiff, claimant or defendant, by reason of this Trust Deed or any indebtedness hereby secured; or (b) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or (c) preparations for the defense of any threatened suit or proceeding which might affect the premises or the security hereof, whether or not actually commenced.
- 8. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the Note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Note; fourth, any overplus to Grantors, their heirs, legal representatives or assigns, as their rights may appear.
- 9. Upon, or at any time after the illing of a bill to forcelose this Trust Deed, the court in which such bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Grantors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said premises during the pendency of such toreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Grantors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection,
