ON THE WORK DONE BY THE DIVISION OF PUBLIC WORKS AND BUILDINGS
DURING THE YEAR ENDING DECEMBER 31, 1918

The following is a summary of the work done by the Division of Public Works and Buildings during the year ending December 31, 1918:

1. Construction of new buildings: 10 buildings, valued at \$1,500,000.

2. Renovation of existing buildings: 20 buildings, valued at \$2,000,000.

3. Maintenance of public works: \$500,000.

4. Construction of bridges: 5 bridges, valued at \$750,000.

5. Construction of sewers: 10 miles of sewer, valued at \$1,000,000.

6. Construction of roads: 100 miles of road, valued at \$1,000,000.

7. Construction of parks: 10 parks, valued at \$1,000,000.

8. Construction of schools: 10 schools, valued at \$1,000,000.

9. Construction of hospitals: 10 hospitals, valued at \$1,000,000.

10. Construction of prisons: 10 prisons, valued at \$1,000,000.

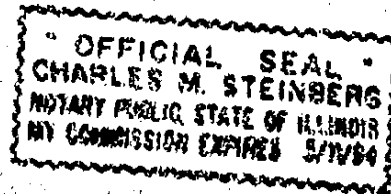
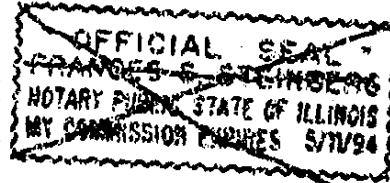
