AN ORDINANCE VACATING A CERTAIN PORTION OF COTTAGE GROVE AVENUE IN THE VILLAGE OF DOLTON, ILLINOIS

The Mayor and Board of Trustees of the Village of Dolton, Illinois, make the following findings of fact:

1. That property commonly known as 820 California is to be conveyed to and utilized to build a church.
2. That after due investigation and consideration by the Village authorities, it has been determined that a certain portion of Cottage Grove Avenue, hereinafter described below and shown on the Plat of Survey attached hereto and made a part of this Ordinance would be best utilized to complete the construction of the church premises.
3. That it has further been determined by said Village authorities that the nature and extent of the public use and public interest to be subserved is such as to warrant the vacation of Cottage Grove Avenue, lying within California Subdivision, be and the same should be vacated, inasmuch as the same is not required for public use and the business interest will be subserved by such vacation.
4. The Village of Dolton would best be served by the conveyance of said portion of Cottage Grove Avenue to the purchaser of 820 California.

NOW THEREFORE BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Dolton, Cook County, Illinois, being a home-rule unit of government, as follows:

1. That:

Cottage Grove Avenue all inclusive in California Subdivision 1st Addition, being a Subdivision of part of the Northeast 1/4 of Section 10 and part of

the Northwest 1/4 of Section 11, Township 36 North, Range 14, East of the Third Principal Meridian, In Cook County, Illinois

according to the Plat of Survey, commonly known as Cottage Grove Avenue in California Subdivision, Dolton, Illinois, be and is hereby vacated.

2. That the Mayor and Clerk are authorized to execute the necessary documents in order to effectuate the conveyance of said portion of Cottage Grove Avenue to the purchaser of 820 California Avenue.

3. That the Clerk of the Village of Dolton be and is hereby authorized and directed to file a true and correct copy of this Ordinance, Plat of Survey and any and all other required documents required to complete vacation and recordation of said property in the Office of the Recorder of Deeds of Cook County, Illinois.

This Ordinance shall be in full force and effect from and after its passage and approval and publication as provided by law.



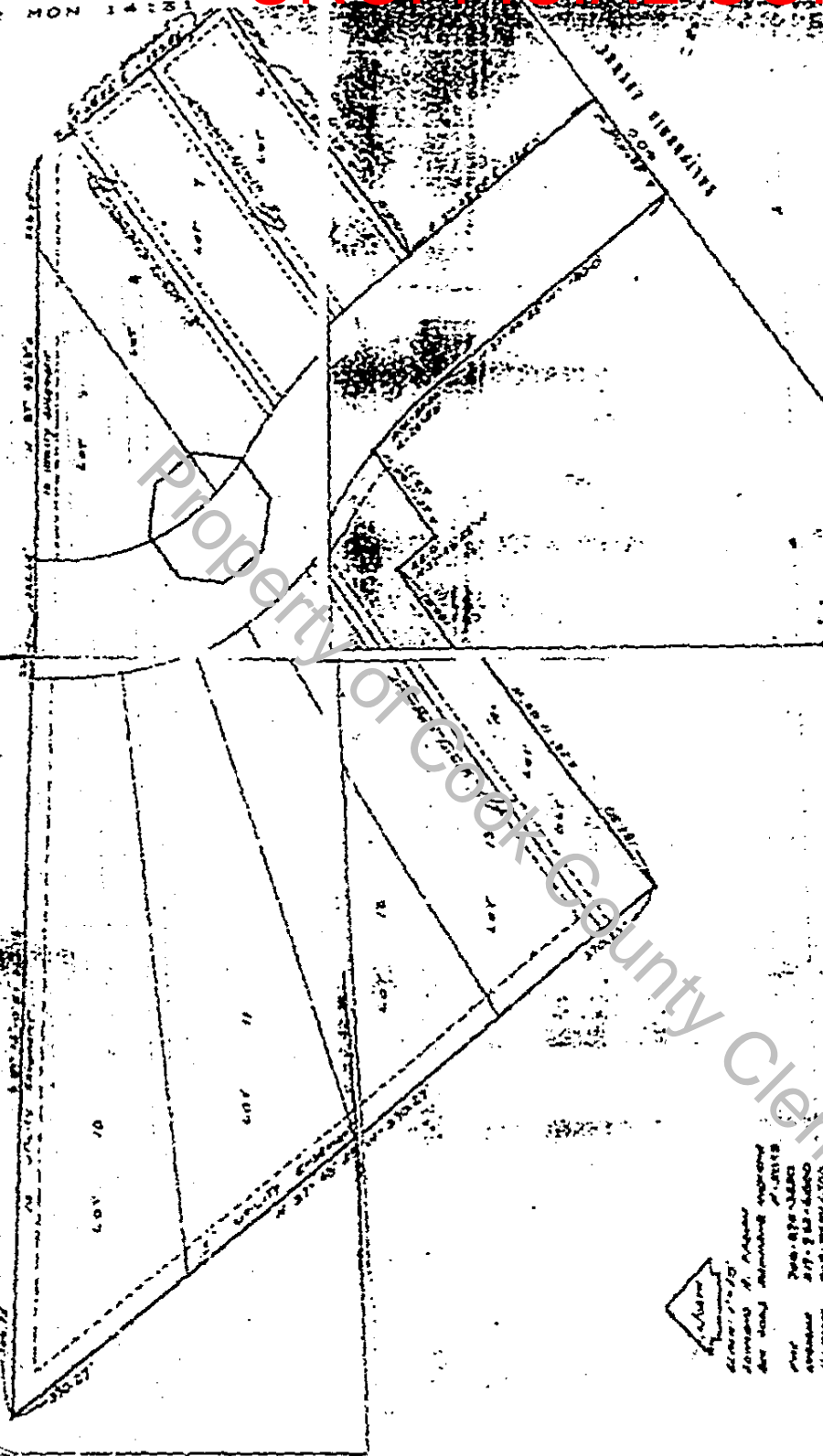
