HOME EQUITY LINE MORTGAGE EXTENSION AGREEMENT

THIS EQUITY LINE MORTGAGE EXTENSION AGREEMENT made and entered into as of the 1ST day of July, 1992, by and between SUCK-OO-KIM AND KYUNG SOON KIM, HIS WIFE, AS JOINT TENANTS, ("Borrowers") and ASSOCIATED BANK, FORMERLY KNOWN AS CHICAGO BANK OF COMMERCE, an Illinois Banking Association ("Lender")

WITNESSETH That:

Borrower has executed and delivered an ASSOCIATED BANK Equity Line Agreement (the "Agreement") dated June 5th, 1987, encumbering certain real property (the "Property") in Cook County, Illinois which Mortgage was recorded on June 19, 1987 as Document Number 87336145, in the Office of the Recorder of Deeds, Cook County, Illinois, which property is legally described therein, to wit:

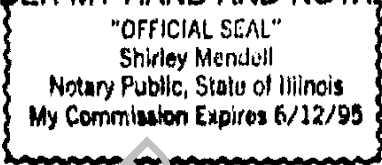
