- b. the fraud and unjust enrichment claims against David Menzel and Jackie Menzel;
- c. the causes of action against Brendan Kwong, individually; and
- d. the breach of contract claims against David Fritsma, David Menzel and Jackie Menzel, individually.

The jury returned a verdict for Oceanside Furniture Shoppe, Inc. as to the claim for breach of contract. The jury returned verdicts for Illinois Capital Group on its claims for breach of contract against Pro Leasing, Inc., and Menzel Associates Incorporated d/b/a Innovative Interiors.

It is ORDERED and ADJUDGED that Oceanside Furniture Shoppe, Inc. go hence without delay and recover costs from Illinois Capital Group in the sum of five hundred fifty-seven dollars and thirty-five cents (\$557.35) that shall bear interest at the rate of twelve (12) percent a year for which let execution; that Illinois Capital Group recover of Pro Leasing, Inc., the sum of three thousand four hundred forty-two dollars (\$3,442.00); and that Illinois Capital Group recover of Menzel Associates Incorporated d/b/a Innovative Interiors the sum of fifty seven thousand three hundred forty-four dollars (\$57,344.00).

It is SO ORDERED in Orlando, Florida, this 18 day of December 1991.
