I/We, ADAM SKINNER and LINA SKINNER, the owner(s) of the property located at 2660 Douglas in the Village of Arlington Heights, Illinois, hereby agree to pay an amount totalling \$22,651.20 for money in lieu of detention in accordance with the current Village Code requirements. (See Attachment A for legal description.)

One-half of the amount due, \$11,325.60, must accompany this signed agreement and be returned to the Engineering Department of the Village of Arlington Heights prior to any permits being issued. The remainder of the money, \$11,325.60 will be due and payable no later than the day that construction is complete. It is understood that, under no circumstances, will a certificate of occupancy, either temporary or final, be issued until the remaining money has been paid.

It is further understood that this Agreement will be recorded against this property and become a liability on the title. If the money due is not paid upon completion of construction, the undersigned agree to have the money due taken from any available source, i.e. letters of credit, bonds, escrow accounts, put up by the undersigned for this project.




