COLLATERAL ASSIGNMENT OF LEASE AND RENTS

THIS ASSIGNMENT is made as of the 27th day of 1992, by American National Bank and Trust Company of Chicago, not personally, but as Trustee under Trust Number 43353 dated July 6, 1978 ("Assignor") to Merchandise National Bank of Chicago, a national banking association, having its principal place of business in Chicago, Illinois ("Assignee");

#### WITNESSETH THAT:

WHEREAS, Assignor and American National Bank and Trust Company of Chicago, as Trustee under Trust Number 46718 dated June 30, 1979, to evidence and secure a loan indebtedness, have made and delivered to Assigner an Installment Note of even date herewith in the principal amount of \$600,000.00 and a Revolving Note of even date herewith in the plincipal amount of \$50,000.00 (both notes hereinafter referred to as the "note"), payable as therein provided, with interest as therein expressed, and have executed and delivered a Mortgage (it being agreed that "mortgage" as hereinafter used shall be construed to mean "deed of trust" or "trust deed" or "deed to secure debt" if the context so requires) bearing the aforesaid date to secure said note on certain real estate in the County of Cook, State of Illinois, more particularly described in Exhibit "A" attached herato and by express reference made a part hereof, including the improvements now or hereafter thereon and the easements, rights and apportenances thereunto belonging, all of which with said real estate being hereinafter called the "mortgaged premises;" and

WHEREAS, Assignee has required the assignment bereinafter made as a condition to making the above loan;

Lesses of the mortgaged premises, or any part thereof, are hereny expressly authorized and directed to pay all rents and other amounts herein assigned to Assignee or such nominee as Assignee may designate in writing delivered to and received by such lessees who are expressly relieved of any and all duty, liability or obligation to Assignor in respect of all payments so made.

Assignee is hereby vested with full power to use all measures, legal and equitable, deemed by it necessary or proper to enforce this Assignment and to collect the rents assigned hereunder, including the right to enter upon the mortgagea premises, or any part thereof, and take possession thereof forthwith to the extent necessary to effect the cure of any default on the part of Assignor as lessor in any of the leases; and Assignor hereby grants full power and authority to Assignee to exercise all rights, privileges and powers herein granted at any and all times hereafter, without notice to Assignor, with full power to use and apply all of the rents and other income herein assigned to the payment of the costs of managing and operating the mortgaged premises and of any indebtedness or liability of Assignor to Assignee, including but not limited to the payment of taxes, special assessments, insurance premiums, damage claims, the costs of maintaining, repairing, rebuilding

It is further understood that this Assignment shall not operate to place responsibility for the control, care, management or repair of the mortgaged premises, or parts thereof, upon Assignee, nor shall it operate to make Assignee liable for the carrying out of any of the terms and conditions of any of the leases, or for any waste of the mortgaged premises by the lessee under any of the leases or any other party, or for any dangerous or defective condition of the mortgaged premises or for any negligence in the management, upkeep, repair or control of said premises resulting in loss or injury or death to any lessee, licensee, employee or stranger.

Assignor shall have the license and right to collect as the same become due and payable, but in any event for not more than one calendar month in advance, all rents and other income arising under the leases and from the mortgaged premises, and to enforce all provisions contained in the leases. Assignor shall render such accounts of collections as Assignee may require. license herein given to Assignor shall terminate immediately upon default in payment of any indebtedness secured hereby or in the performance of any other obligation, covenant or agreement of Assignor contained in said note or the mortgage, or in this Assignment, or in any of the leases (after all applicable grace periods have expired); and, upon written notice of Assignor's default it any time hereafter given by Assignee to any lessee by mailing same by United States registered mail, postage prepaid, addressed to the lessee named in the lease, all rentals thereafter pryable and all agreements and covenants thereafter to be performed by the lessee shall be paid and performed by the lessee directly to Assignee in the same manner as if the above license had not leen given, without prosecution of any legal or equitable remedies under the mortgage. Any lessee of the mortgaged premises of any part thereof is authorized and directed to pay to Assignor any rent herein assigned currently for not more than one calendar month in advance and any payment so made prior to receipt by such lessee of notice of Assignor's default shall constitute a full acquittance to lessee therefor.

This assignment is executed by American National Bank and Trust Company of Chicago, not personally, but as Trustee as aforesaid in the exercise of the power and authority conferred upon and vested in it as such trustee, and said Trustee hereby warrants that it possesses full power and authority to execute this instrument. It is expressly understood and agreed that nothing herein or in the Note contained small be construed as creating any liability on Assignor personally to pay the Note or any interest that may accrue thereon, or any indebtedness accruing thereunder, or to perform any covenant, either express or implied, herein contained (it being understood and agreed that each of the provisions hereof, except the warranty hereinabove contained in this execution clause, shall constitute a condition and not a covenant or agreement, regardless of whether the same may be couched in language of a promise or covenant or agreement), all such liability, if any, being expressly waived by Assignee and by every person now or hereafter claiming any right or security hereunder, and that so far as Assignor and its successors personally are concerned, the holders and the owner or owners of any indebtedness accruing hereunder shall look solely to any one or more of: (a) the mortgaged premises and the rents, issues, and profits thereof for the payment thereof by the enforcement of the lien hereby created, in the manner herein and in the Note provided; (b) assets of the Trust Estate held under the Trust Agreement; (c) any other security given to secure said Indebtedness; or (d) the personal liability of the guarantor.
