THIS LIEN is made this 28TH day of August, 1992, by STANDARD BANK AND TRUST COMPANY OF HICKORY HILLS as trustee under Trust agreement Dated January 31, 1987 and known as Trust #3087 ("Trustee"), in favor of the United States Government. This instrument constitutes a lien in the amount of \$19,292.88 on the real estate described below (the "Subject Property"). The rights of the United States Government shall take precedence over any subsequent lien or encumbrance until this lien is formally released by a duly authorized representative of the United States. Trustee hereby grants the United States the power to sell the Subject Property, including the right to satisfy its reasonable administrative costs, including legal fees associated with any sale of Subject Property, in the event of contractor default if the individual surety otherwise fails to satisfy the underlying performance bond obligations on contract # GS-03P-90-DWC-0312. The lien is upon the real estate owned by Trustee and described as follows:

Lot 292 of Leslie C. Barnard's Palos on the Green, Unit 4, a subdivision of part of the East one-half (1/2) of the Northwest Quarter (1/4) of Section 14, Township 37 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.






