SUB-SUBCONTRACTOR'S CLAIM FOR A MECHANICS' LIEN

1. They entered into a oral contract with Strike Force Plumbing and Heating, as sub-contractors and Ben A. Borenstein & Co., as general contractors and Moo & Oink, Inc., as owners to furnish and deliver certain plumbing materials and labor in connection therewith. The Claimant did furnish certain plumbing materials and labor in connection therewith pursuant to the written agreement on the premises commonly known as: 7158 South Stony Island, Chicago, Illinois.

The legal description of which is as follows:

2. That said oral agreement described the very nature of the materials to be supplied and the work to be undertaken and performed by said Claimant, for which Strike Force Plumbing and Heating, Ben A. Borenstein & Co., and Moo & Oink, Inc., agreed to pay and to otherwise compensate said Claimant on the basis in the amount of \$ 11,772.99.

3. That said Claimant did furnish, perform and otherwise complete all of the work, labor and materials required on its part pursuant to the oral agreement in a good workmanlike manner and in accordance with the express understanding of the parties, with the knowledge, consent and authority of Ben A. Borenstein & Co., and Strike Force Plumbing and Heating, as the general contractor and the sub-contractor respectively, and Moo & Oink, Inc., as owners.

4. That the last day on which labor and materials furnished, was on to-wit: June 23, 1992. At such time, there became due and owing to said Claimant, the sum of \$11,772.99, under said oral agreement after allowing all just credits, deduction and set-offs.

5. That demand was made upon Strike Force plumbing and Heating as the subcontractor and ben A. Borenstein & Co., as the general contractor and Moo & Oink, Inc., as the owners and each of them have failed and refused to make payment therefor.

6. This Claimant accordingly possesses the right to a Mechanics' Lien on and against the aforescribed real estate, the land and improvements thereon. That by reason of the very nature and character of the work, labor and materials furnished, performed and otherwise completed on said real estate, by said Claimant, there has been an enhancement in the value of said real estate to the extent of the amount of the Claimant's Claim for a Mechanics' Lien and therefore said Lien shall be and become a prior, paramount and

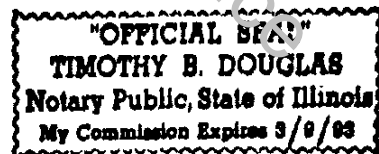
