AMENDED ORDER FOR DISPOSITION OF PROPERTY PURSUANT TO STIPULATION



#### DISMISSAL BY STIPULATION

It is hereby stipulated and agreed by and between the UNITED STATES OF AMERICA, by its attorney, ANTON R. VALUKAS, the United States Attorney for the Northern District of Illinois, and claimants, STEPHEN PERRY and MARTHA JACKSON, a/k/a MARTHA PERRY, by their attorneys Serpico, Novelle, Dvorak & Navigato, Ltd., pursuant to Rule 41 (a) (1) (ii) of the Federal Rules of Civil Procedure, to dismiss this cause of action by stipulation. - 4. The United States of America, after costs will pay to Claimant Kartha Jackson, a/k/z Martha Perry; one-half of the proceeds from the sale of the defendant property.
- Jackson, a, k/a Hartha Perry, claimants herein, release and forever discharge, and for their heirs, executors, administrators, successors and assigns hereby release and forever discharge, the UNITED STATES OF AMERICA, its agents, agencies, officials and employees from any and all claims, demands, rights and causes of action arising from and by reason of any known and unknown, foreseen and unforeseen personal injuries, damages, and violations of any rights, whether they be pursuant to the state or federal constitutions, any statute or common law, and any consequences thereof, resulting from the
