THIS MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTS, executed this 14th day of September, 1992, by HERITAGE TRUST COMPANY, as Successor Trustee to Heritage Bromen Bank and Trust Company, NOT PERSONALLY, BUT SOLELY AS TRUSTEE UNDER TRUST AGREEMENT DATED MAY 12, 1988 AND KNOWN AS TRUST NO. 88-3316 (hereinafter interchangeably referred to as "Mortgagor" or "Borrower"), to THE STEEL CITY NATIONAL BANK OF CHICAGO, having its principal office and place of business at 3030 East 92nd Street, Chicago, Illinois 5/617 (hereinafter interchangeably referred to as "Mortgagee," "Lender" or "Bank").

WITNESSETH:

WHEREAS, Mortgagor is justly indebted to Mortgages in the sum of EIGHT HUNDRED THIRTY NINE THOUSAND CHIRTY THREE AND NO/100 (\$839,033.00) DOLLARS in lawful money of the United States, and has agreed to pay the same, together with interest thereon, which rate of interest may vary from time to time, on or before December 14, 1992, according to the terms and provisions of a certain promissory note dated September 14, 1992, made by Mortgagor to the order of Mortgages (hereinafter referred to as the "Note"), which Note represents a loan made by Mortgages to Mortgagor.

yearly premium installments for mortgage insurance, if any, and (e) if this Mortgage is on a leasehold, the yearly fixed rents, if any, under the ground lease, all as reasonably estimated initially and from time to time by Mortgages on the basis of assessments and bills and reasonable estimates thereof. Any waiver by Mortgages of a requirement that Mortgager pay such Funds may be revoked by Mortgages, in Mortgages's sole discretion, at any time upon notice in writing to Mortgager. - 1.05 Performance by Mortgagee.
