AN ORDINANCE ANNEXING CERTAIN TERRITORY
INTO THE VILLAGE OF STREAMWOOD, COOK COUNTY, ILLINOIS

WHEREAS, a written petition signed by the legal owner of record of all land within the territory herein described has been filed with the Village Clerk of the Village of Streamwood, Cook County, Jilinois requesting that said territory be annexed to the Village of Streamwood; and

WHEREAS, the territory is not within the corporate limits of any municipality, but is contiguous to the Village of Streamwood; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of said annexation agreement and with the statutes of the State of

WHEREAS, it is in the best interest of the Village of Streamwood that said territory be annexed thereto.

SECTION TWO: That the Village Clerk is hereby directed to record with the Recorder of Deeis and to file with the County Clerk, a certified copy of this Ordinance together with the accurate map of the territory annexed appended to this Ordinance.

SECTION THREE: That this ordinance shall be in full force and effect from and after its passage, approved and publication in pamphlet form as provided by law.
