THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS PRFERED TO ON-PAGE 1 (THE MEVERSE SIDE OF THIS TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagars shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or herestier on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics tiens or liens in lawar of the United States or other liens or claims for tien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory exilence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings onto or a lany time in process of exection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material aftersions in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the nage.
- 2. Aforigagors shall pay before any penalty assaches all general taxes, and shall pay special taxes, special passestments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Tristee crito holders of the note the original or duplicate receipts therefor. To prevent default hereunder Morigagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which hiorigagors may desire to contest.
- digraphing and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or replating the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidented by the standard mortage clause to be attached to each policy, and shall deliver all policies, including additional and renewal moticies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than sen days prior to the respective dates of expiration.
- In case of default therein. Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discherge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable autorneys less, and any other moneys advanced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorizes may be taken, shall be so much additional indebtadness secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate of nine per cent per annum, inaction of Trustee or holders of the note shall never be considered as a waiver of any tight accruing to them on account of any default hereunder on the part of Murtgagors.
- 5. The Trustee or the holders of he note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or calibrate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity r. any lax, assessment, sale, forfeiture, tax lien or title or cialm thereof.

- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be fits Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust.
