





ORDINANCE #93-10

AN ORDINANCE PERTAINING TO THE ANNEXATION OF CERTAIN TERRITORY INTO THE DOMAIN OF THE PALATINE PARK DISTRICT

WHEREAS, the Palatine Park District is a park district organized and existing under the provisions of the Park District Code approved on May 17, 1951, as amended; and,

WHEREAS, Section 3-10 of the Park District Code provides:

"Whenever a Park District operating within territory predominately in a City or Village or two or more Cities or Villages would become conterminus or nearly conterminus with such City or Village or two of more Cities or Villages upon the annexation of additional territory with such municipalities but not incorporated within a park district, such park district may annex such additional territory by passage of an Ordinance to that effect," and,

WHEREAS, the territory described herein lies within the corporate boundaries of the Village of Palatine, but does not presently lie within the Corporate boundaries of the Palatine Park District; and,

WHEREAS, the Palatine Park District is presently operating within a territory predominately within the corporate limits of the Village of Palatine; and,

WHEREAS, upon the annexation of the territory described herein, the boundaries of the Palatine Park District and the Village of Palatine will become nearly co-terminus;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS of the Palatine Park District, situated in the County of Cook, State of Illinois, that:

<u>Section 1</u>. The territory hereinafter described shall be and it is hereby annexed into the domain of the Palatine Park District.

<u>Section 2</u>. The territory hereby annexed is located on the east side of Quentin Road, approximately 1/2 mile south of Lake-Cook Road and is legally described as follows:

PARCEL 1: THAT PART OF THE BAST HALF OF LOT 1 OF THE GOVERNMENT DIVISION OF THE NORTHWEST QUARTER OF SECTION 3, TOWNSHIP 42 NORTH, RANGE 10, BAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, DESCRIBED AS FOLLOWS:

PARCEL 3: THAT PART OF THE EAST HALF OF LOT 1 OF THE GOVERN-MENT DIVISION OF THE NORTHWEST QUARTER OF SECTION 3, TOWNSHIP 42 NORTH, RANGE 10, BAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF HIDDEN VALLEY SUBDIVISION; THENCE S O -00'-40" E ALONG THE WEST LINE OF THE TAST HALF OF THE GOVERNMENT LOT 1 FOR 163 FEET; THENCE EAST 66 FEET FOR A PLACE OF BEGINNING; THENCE S O -00'-40" E FOR 212.09 PERT: THENCE N 66 -46'-20" E FOR 73.18 FEET TO A POINT OF CURVATURE; THENCE NORTHEASTERLY ALONG A CURVE TY THE LEFT HAVING A RADIUS OF 180 PEET POR 115.57 PEET TO LEGINT OF REVERSE CURVATURE; THENCE NORTHEASTERLY ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 120 PEET POR 87.86 PEET; THENCE N 59 -44'-37" W FOR 106.48 FEET; THENCE WEST FOR 126.97 FEET TO THE POINT OF BEGINNING. 9271277

CONTIGUITY PARCEL: THE EAST 200 FEET OF THAT PART OF THE SOUTH 500 FEET OF THE EAST HALP OF THE SOUTHWEST QUARTER OF SECTION 3 LYING NORTH OF THE NORTH LINE OF DUNDEE ROAD, AND ALSO THE WEST 200 FEET (EXCEPT THE SOUTH 300 FEET THEREOF) OF THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 3, AND ALSO THE WEST 200 FEET (EXCEPT THE NORTH 200 FEET THEREOF) OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 3, ALL IN TOWNSHIP 42 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.
