- The rights, powers and authority of said attorney in fact granted in this instrument shall be in full force and effect until said transaction is consummated relating to the above real estate.

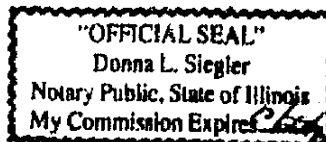

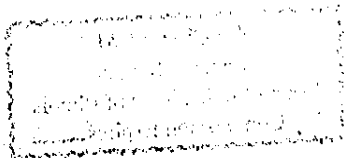

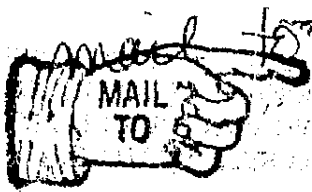
