UNIFORM COVENANTS, Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt; evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. 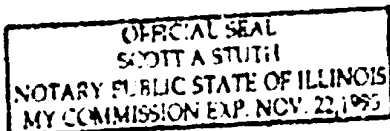
