



#### AGREEMENT BETWEEN THE CITY OF PROSPECT HEIGHTS AND THE VILLAGE OF WHEELING REGARDING THE INCLUSION OF CERTAIN PROPERTY IN PROSPECT HEIGHTS SPECIAL SERVICE AREA NUMBER ONE


