That said contractor is entitled to credits on account thereof as follows: none

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of SEVEN THOUSAND FOUR HUNDRED FIFTY-SIX and 35/100 + mo. serv. chg. and fees Dollars, for which, with interest,

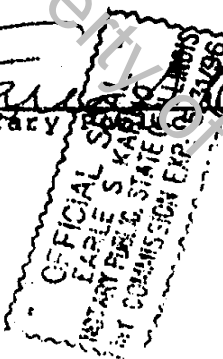
