ASSIGNMENT OF RENTS

Assignment. The word "Assignment" means this Assignment of Rents between Grantor and Lender, and includes without limitation all assignments and security interest provisions relating to the Pients

Event of Default. The words "Event of Default" mean and include any of the Events of Datault set forth below in the section titled "Events of Default."

Grantor. The word "Grantor" means JOSEPH P. ATRIA and SONIA M. / TF.A

indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to referce obligations of Grantor under this Assignment, together with interest on such amounts as provided in this Assignment.

Lender. The word "Lender" means Avenue Bank of Oak Park, its successors and assir.is.

Note. The word "Note" means the promissory note or credit agreement dated September 25, 1992, in the original principal amount of \$107,000.00 from Grantor to Lender, together with all renewals of, extensions of, murifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. Real Property. The words "Real Property" mean the property, interests and rights described above in the "Property Definition" section.

Reisted Documents. The words "Related Documents" mean and include without limitation all promissory notes, credit agreements, loan agreements, guaranties, security agreements, mortgages, deeds of trust, and all other instruments, agreements and documents, whether now or reference adding, executed in connection with the Indebtedness.

Rents. The word "Rents" means all rents, revenues, income, Issues, and profits from the Property, wheth... do now or later, including without [imitation all Rents from all leases described on any exhibit attached to this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF AND ALL OBLIGATIONS OF GRANTOR UNDER THE NOTE, THIS ASSIGNMENT, AND THE RELATED DOCUMENTS. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment, Grantor shall pay to Lender all amounts secured by this Assignment as they become due, and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender exercises its right to collect the Rents as provided below and so long as there is no default under this Assignment, Grantor may remain in possession and control of and operate and manage the Proporty and collect the Rents, provided that the granting of the right to collect the Rents shall not constitute Lender's consent to the use of cash collateral in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Grantor represents and warrants to Lender that:

Ownership. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lunder In writing.

Right to Assign. Grantor has the full right, power, and authority to enter into this Assignment and to assign and convey the Renis to Lender.

No Prior Assignment, Grantor has not previously assigned or conveyed the Rents to any other person by any instrument now in force.

No Further Transfer. Grantor will not self, assign, encumber, or otherwise dispose of any of Grantor's rights in the Rents except as provided in this Agreement.

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenents. Lender may send notices to any and all tenents of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the tenants or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.

Maintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of all services of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the Property.

Compliance with Laws. Lender may do any and all things to execute and comply with the laws of the State of fillnois and also all other laws,

Lease the Property. Lender may rent or lease the whole or any part of the Property for such terms and on such conditions as Lender may deem appropriate.

EXPERIENTUATED BY LENDER. Breaches. Any warranty, representation of stament made or furnished to Lender by or on bohalf of Grantor under this Assignment, the Note or the Related Documents is, or at the time make or furnished was, false in any material respect.

Other Defaults. Failure of Grantor to comply with any term, obligation, covenant, or condition contained in any other agreement between Grantor and Lender.

Insolvency. The insolvency of Grantor, appointment in preceiver for any part of Grantor's property, any assignment for the benefit of creditors, the commencement of any proceeding under any backrubly or insolvency laws by or against Grantor, or the dissolution or fermination of Grantor's edelence as a going business (if Grantor is a Difference). Except to the extent prohibited by federal law or Minols law, the death of Grantor is an individual) also shall constitute an Event of Default under this Assignment.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time theregier, Lander may axercise any one or more of the following rights and remedies, in addition to any other rights or remedies provide a by law:

Accelerate indebtedness. Lender shall have the right at its option without notice to Grento to declare the entire indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.

Collect Rents. Lander shall have the right, without notice to Grantor, to take possession of the Picophy and collect the Rents, including amounts past due and unpeld, and apply the net proceeds, over and above Lender's costs, against the individences. Applicable Law. This Assignment has been dollvered to Lender and accepted by Lender in the State of Illinois. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois.

Multiple Parties. All obligations of Granfor under this Assignment shall be joint and several, and all references to Granfor shall mean each and every Granfor. This means that each of the persons signing below is responsible for all obligations in this Assignment.

No Modification. Grantor shall not enter into any agreement with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Assignment by which that agreement is modified, amended, extended, or renewed without the prior written consent of Lender.
