- 2. The registered office must include a street or road address, a post office box number alone is not acceptable.
- 3. A corporation cannot act as its own registered agent.

- If the registered office is changed from one county to another, then the corporation must file with the recorder 4. of deeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of change of registered critice. Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered agent has be by resolution adopted by the board of directors. This statement must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- 8. The registered agent may report a chings of the registered office of the corporation for which he or she is County Clark's Office registered agent. When the agent reports such a change, this statement must be signed by the repistered agent.
