EXHIBIT A

LEGAL DESCRIPTION

THAT PART OF THE NORTH EAST 1/4 OF THE NORTH EAST 1/4 OF SECTION 32, TOWNSHIP 41 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE POINT OF INTERSECTION WITH A LINE 33.00 FEET EAST OF AND PARALLEL WITH THE WEST LINE OF THE NORTH EAST 1/4 OF THE NORTH EAST 1/4 OF SECTION 32 AFORESAID WITH A LINE 50.0 FEET SOUTH OF AND PARALLEL WITH THE NORTH LINE OF THE NORTH EAST 1/4 OF SAID SECTION 32; THENCE EAST ALONG THE LAST DESCRIBED PARALLEL LINE, 653.0 FEET; THENCE SOUTH PERPENDICULAR TO SAID PARALLEL LINE, 800.0 FEET; THENCE WEST PARALLEL WITH THE NORTH LINE OF THE NORTH EAST 1/4 OF SECTION 32, AFORESAID 487.80 FEET TO THE POINT OF BEGINNING OF THE FOLLOWING DESCRIBED TRACT OF LAND; THENCE CONTINUING WEST ALONG SAID PARALLEL LINE 201.00 FEET TO A POINT ON A LINE 33 FEET EAST OF AND PARALLEL WITH THE WEST LINE OF THE NORTH EAST 1/4 OF THE NORTH EAST 1/4 OF SECTION 32 AFORESAID, THENCE SOUTH ALONG THE LAST DESCRIBED PARALLEL LINE 443.937 FEET TO POINT ON A LINE 33.0 FEET NORTH OF SAID PARALLEL WITH THE SOUTH LINE OF THE NORTH EAST 1/4 OF THE NORTH EAST 1/4 OF SECTION 32 AFORESAID.
