LAST WILL

OF

TILLIE WOJCIECHOWSKI

I, TILLIE WOJCTECHOWSKI, residing in the City of Chicago, County of Cook, State of Illinois, and being of sound minu and disposing memory, do hereby make, publish and declare this to be my Last Will, and I do hereby expressly revoke any and all other Wills and codicils by me heretofore made.

ARTICLE I

I hereby order and direct that all my just debte, funeral expenses and costs of administration be paid out of my estate as soon as possible after my decease.

ARTICLE II

All inheritance, estate and succession taxes (including interest and penalties thereon payable by reason of my death) shall be paid out of and be charged generally against the principal of my residuary estate without reimbursement from any person; except that this provision shall not be construed as a waiver of any right which my Executor has, by law or otherwise, to claim reimbursement for any such taxes which become payable on account of property, if any, over which I have a power of appointment.

ARTICLE III

I give to my daughter Dolores Wojciechowski all my household goods, furnishings, and furniture.

ARTICEL IV

I give to each of the following who survive me the sum set opposite his name:

My grandson Michael Wojciechowski

Three Thousand Dollars (\$3,000.00)

My grandson Richard Wojciechowski

Two Thousand Dollars (\$2,000.00)

My grandson Edward Wojciechowski

Three Thousand Dollars (\$3,000.00)

ARTICLE V

I give, devise and bequeath the residue of my estate, real, personal, and mixed, of whatsoever kind and character, wheresoever the same be situate, to my children Ronald Wojciechowski and Dolores Wojciechowski, or if either does not survive me, per stirpes to my descendants who survive me.

ARTICLE VI

I intend on my death any property in my name and that of another as tenants by the entireties or joint tenants with the right of survivorship, or which is in my name as trustee for the benefit of a named beneficiary, or which is payable to a co-owner, survivor, or named beneficiary will pass to the survivor or beneficiary, and I instruct the Executor to make no claim thereto.

ARTICLE VII

Any indebtedness and interest thereon due to me from any descendant or spouse of a descendant of mine shall be allocated to the descendant's share.

ARTICLE VIII

Any debt owed by me and secured by real or personal property, our excluding debts covered by creditor life insurance on my life, shall be paid out of my estate, rather than out of the security. To the extent the debt is paid from the security, the executor shall reimburse the legatee or beneficiary.

ARTICLE IX

If any person takes any action to prevent the admission to probate or to contest the validity of this Last Will, that person shall take nothing hereunder.

ARTICLE X

No person named in this Last Will shall be deemed to have survived me unless he or she is living on the thirtieth day succeeding the day of my death.

ARTICLE XI

I name my son Ronald Wojciechowski as Executor of this Last Will. If for any reason my son Ronald Wojciechowski fails or ceases to act as Executor, then I name my grandson Michael Wojciechowski as Executor. I direct no security on the Executor's bond be required of Ronald Wojciechowski or Michael Wojciechowski.

ARTICLE XII

I give the Executor the following powers and discretions in each case to be exercisable without court order:

- (a) To sell at public or privite sple, to retain, to lease, to borrow money and for that purpose to mortgage or to pledge all or part of the real or personal property of my estate;
- (b) To settle claims in favor of or against my estate;
- (c) To exercise or not to exercise any election of option granted to executors by the Internal Revenue Code in force at my death, even though such exercise or non-exercise increases or decreases estate principal or income, without adjustment to principal or income;
- (d) To distribute the residue of my estate in cash or in kind or partly in each, and for this purpose the determination of the Executor as to the value of any property distributed in kind shall be conclusive; and
- (e) To execute and deliver any deeds, contracts, mortgages, bill of sale or other instruments necessary or desirable for the exercise of (his) (her) powers and discretions as Executor.

ARTICLE XIII

I direct independent administration of my estate.

ARTICLE XIV

If any beneficiary of mine has not attained legal age at the time any property becomes distributable to him or her, the Executor may distribute the property to a custodian under any Uniform Gifts To

Minors Act. Alternatively my Executor may retain the property or distribute it to anyone with whom the beneficiary is residing in trust for the following purposes: The Trustee shall pay to the beneficiary such amounts from the income and principal of the property as the Trustee may deem appropriate, adding to principal any income not thus paid. When the beneficiary reaches the age of twenty-one years, any remaining property shall be distributed to him, or if he dies under that age, to his personal representative. The receipt and written undertaking of the distributee shall discharge the Executor.
