#### A) Change Date

The most recent Index figure available as of forty five (45) days before the Change Date is called the "Current Index". If the Index is reported as a range of rates, the Index used will be the highest

Before the Change Date, the Note Holder will calculate my new interest rate by referring to the Current Index. Subject to the limits stated in Section 4(D) below, the Current Index will be my new interest rate.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that Tam expected to owe at the Change Date in full on the maturity date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment

#### Lifetime Marinum and Minimum Interest Rate D)

The interest rate I am required to pay will never be greater than 9.50 percent and will never be lower than 8.50 percent.

### Effective Date of Changes

My new interest rate will become effective on the Change Date. I will pay the amount of my new monthly payment beginning on the first monthly payment date after the Change Date.
