PARTIAL RELEASE DEED

KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does hereby release to Harris Bank Barrington, as Trustee Under Trust Agreement dated June 11, 1990 and known as Trust Number 11-44-33, all the right, title, interest, claim or demand whatsoever it may have acquired in, through or by that certain Mortgage and Security Agreement with Assignment of Rents dated August 20, 1990 and recorded August 24, 1990 as Document No. LR-3-906-725, Assignment of Leases and Rents recorded August 24, 1990 as Document No. LR-3-906-726 and Financing Statement No. LR-3-906-727 and 90 U 18208 recorded August 24, 1990 in the premises described below situated in the County of Cook, State of Illinois, as follows, to-wit: PIN 02-06-14-01-0

Lot 63 in Lakewood subdivision, a subdivision in the southwest quarter of the northwest quarter of Section 6, Township 42 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois, as filed in the registrar of Deeds of Office on August 24, 1990 as Document Number LR 3-906-723.
